Introduction

Congratulations! Your new Voice Pad™ is a unique and useful book card that lets you record and play back voice messages on your BOOKMAN®

You can carry the Voice Pad in your BOOKMAN or take it out and carry it separately. Either way, your messages are saved without the need for extra batteries.

The Voice Pad provides 20 sec-


onds of total recording time in which you can record as many messages as you like. Record brief reminders to yourself or leave messages for others.

The Voice Pad is easy to use. Just follow the steps in this User's Guide. And to get even more from your Voice Pad, read the special tips marked with a key icon.

Installing the Voice Pad

Because the Voice Pad has no batteries of its own, it will operate only when installed in your BOOKMAN and when your BOOKMAN is turned off.

- 1. Turn off your BOOKMAN.
- 2. Turn over your BOOKMAN.
- 3. Align the tabs of the Voice Pad with the notches in the slot.



4. Press the Voice Pad down until it snaps into place.



If you try to use an installed Voice Pad when your BOOKMAN is turned on, the Voice Pad won't work. However, you won't damage your BOOKMAN or any other installed book cards if you leave your Voice Pad in a card slot when you're not using it.

Within the 20 seconds of recording time available on the Voice Pad, you can record as many messages as you like.

- Make sure that the Voice Pad is installed in your BOOKMAN and that your BOOKMAN is turned off.
- 2. Hold the installed Voice Pad about two-to-six inches from your mouth.
- 3. Press and hold the red RECORD button.

Notice that the recording/end-of-message light goes on.

- 4. Speak directly into the speaker/microphone.
- 5. When you're finished speaking, release the RECORD button. If the recording/end-of-message light goes off before you release the RECORD button, the 20-second total time for messages ran out.
- 6. To record the next message, repeat these steps.



To erase a message, go to the start of that message and then record over it. For example, if you recorded three messages on your Voice Pad and wanted to keep the first two, you would press RESET, play the first two messages, and then hold RECORD.

Please note, however, that when you're recording over a message, there is no warning that you're not also recording over subsequent messages.

Playing Messages

Playing your messages is easy. Just use the RESET and PLAY buttons.

- Press the blue RESET button to reset the Voice Pad to the start of the first message.
- 2. Press the green PLAY button to hear the first message.
- Press PLAY again to hear the other messages, if any. Notice that the recording/end-of-message light briefly flashes at the end of each message.
- 4. To return to the start of the first message, press RESET.



Keep these tips in mind when playing your messages:

- Immediately after recording a message, you can press PLAY to reset the Voice Pad and hear the first message.
 At all other times, pressing PLAY plays the next message on the Voice Pad.
- When you're playing a message, you can't record a new message or reset the Voice Pad to its first message.
- Don't worry about losing your recorded messages. You can remove the Voice Pad from your BOOKMAN for any period of time, reinstall it, and then play your messages.

Problem

 When I press the buttons on the Voice Pad, nothing happens.

I've recorded messages, but when I press the PLAY button, I don't hear a message.

Possible Solution

- The Voice Pad won't work if it isn't installed in your BOOKMAN and your BOOKMAN is turned off. Please read "Installing the Voice Pad" to learn how to get your Voice Pad ready for use.
- The RECORD button starts recording whenever it is pressed.
 if you inadvertently press RECORD without speaking into the Voice Pad, a wordless "message" will be recorded. Later, when you press PLAY, you'll hear that blank message.

You can check to see if this is the case by watching the recording/end-of-message light when you press PLAY. If it flashes, some "message" was played. To get rid of blank messages, simply record over them.

Caution: Touching these electrical contacts with statically charged objects, including your fingers, could erase information entered in a book card.





 Do not put excessive weight on your book cards.





 Do not expose your book cards to heat, cold, or liquids.

The first time that you use your new Voice Pad™, follow these steps. You'll learn how to hear the prerecorded messages, if any, and how to record and play your first message. Then read the User's Guide for more details.

- 1. Turn off your BOOKMAN.
- 2. Install the Voice Pad in your BOOKMAN.

If your BOOKMAN has more than one book card slot, install the Voice Pad card in the slot on the left. (See the other side of this page.)

- 3. Press the green PLAY button on the Voice Pad to hear the first prerecorded message, if any.
- 4. Press PLAY again to hear the second prerecorded message.
- 5. Press the blue RESET button.
- Hold the red RECORD button and speak directly into the Voice Pad to record a message.

Notice that the recording/end-of-message light goes on.


7. Press PLAY to hear your message.



The Voice Pad can record up to 20 seconds of messages. When all 20 seconds are recorded, the recording/end-of-message light will not light when you press RECORD. When that is the case, you must press RESET before you can record a new message over an existing message.

To use the Voice Pad™ in a BOOKMAN unit that has two book card slots, you must install the Voice Pad card in the slot on the left, as shown below.
